### **Bill History Since April 18:**

- April 22: ALETF AB 524 Subcommittee Position Letter submitted to Assembly Agriculture Committee
- May 1: Passed the Assembly Agriculture Committee (8–0), referred to the Assembly Appropriations Committee
- May 23: Passed the Assembly Appropriations Committee (14–0)
- June 2: Passed the Assembly (76–0)
- June 11: Referred to the Senate Committees on Agriculture and Natural Resources & Water
- June 24: Passed the Senate Committee on Natural Resources & Water (6–1) and sent to the Senate Agriculture Committee

#### **Bill Amendments**

#### New Co-Authors (May 1):

Members Aguiar-Curry, Alanis, Jeff Gonzalez, Hadwick, Irwin, Ransom, and Soria

#### Text Amendments (April 22):

"...a qualified entity that receives a grant for financial assistance under the program shall do either of the following within five years of acquiring agricultural land with the financial assistance provided under the program:"

- 1. "Transfer the agricultural land to a qualified farmer participant..."
- 2. "Enter into a long-term lease with a qualified farmer participant in accordance with all of the following criteria:"

(D) "After the initial lease term, the lease authorizes the qualified farmer participant and qualified entity to pursue a lease-to-own agreement where the qualified farmer participant would be eligible to purchase the fee title from the qualified entity."

(D) "The lease provides the qualified farmer participant with the opportunity to purchase the land at or before the end of the lease term through a purchase option or a lease-to-own provision in the lease agreement."

### Legislative Session Timeline:

- Present Day: Bills are being considered in the second chamber
- July 18: Deadline for policy committees to consider bills
- July 18–August 18: Summer recess
- August 29: Last day for fiscal committees to meet and report bills for full chamber consideration
- September 12: Last day for second houses to pass bills
- October 12: Last day for governor to sign or veto bills
