#### **Council Comment:**

Chancellor Munoz: Appreciates intentionality behind awards to Tribal communities is remarkable. Communities have often been overlooked, and \$2 million is a starting point.

Secretary Ross: Appreciate seeing legislature paying close attention to our programs and seeing where need lie. Wants to reinforce importance of advance pay pilot program.

Secretary Castro-Ramirez: Grateful for legislature and the Governor for signing strong bills that will expand building affordable housing. We're excited for the opportunity to work with local communities to reposition and reimagine commercial corridors that are underutilized and creating housing that is affordable and mixed use. Looking at points of intersection with community resilience centers and housing that is being built in those communities as we continue to build on guidelines.

Deputy Secretary D'Souza: Want to highlight bills that were not called out in the update. Wanted to draw connection with the work we do and the climate bills that also passed.

Councilmember Cardenas: SGC was completing review on AB285 back in June. Some of us are disappointed with the fate of the bill which was AB2438. What was the spirit of this bill being revived? Funding for community resilience centers is a real game changer and interested in hearing from staff how this might interface with existing projects like AHSC and TCC.

#### **Council Comment:**

Deputy Secretary Moreno-Rivera: Wants to thank members of the public for all your engagement and providing your testimony on behalf of your community.

Secretary Ross: Happy to see the enthusiasm and wants to thank communities.

Secretary Castro-Ramirez: Thank you for participating and sharing your perspective. It makes a difference to hear from you and bring to life components of this program. TCC is a community-led program, and we see how this program brings meaningful participation. Excited to see projects and thanks for staff to thinking about how to provide planning grants. For applicants that applied and did not score high enough, we have limited resources but sense of hope to apply again.

Secretary D'Souza: Thank you for coming to this meeting, especially those coming from South LA, it's a long journey. We value the work your communities are doing and thank you for SGC teams for the work they have been doing. We support the suggestions made today. I would like to see smaller less-resourced communities like Coachella be successful in the future.

Deputy Secretary Mirzazad: It means a lot to have communities share their experiences and perspective here today. Repeat applicants show how meaningful and supportive communities have been to move initiatives forward. It's exciting to see South LA receive award today. We don't want to recreate racism. What's happening in LA is really showing what we don't want to happen and making sure we support each other during this time. #### **Council Comment:**

Chancellor Munoz: What percentage of this funding will go to consultants and why would we need to pay for SGC personnel?

Secretary Ross: Is there any consideration that all travel costs of members will be covered? It's very important to pay for stipends of the input of folks and be inclusive of that. In 2020, we released the first ever Farm Equity Report. One of the greatest barriers for farmers is access to land. Land values and competing interest for lands makes it difficult for new, and diverse farmers. Urban farming provides an outlet for new beginning farmers and immigrant farmers. I'm enthusiastic about this item on our agenda and support staff recommendations.

Deputy Secretary Moreno-Rivera: We have some suggestions for language choice and for consistency as we take this forward. We also have some clarifying questions that we would appreciate being answered as a follow-up.



Chancellor Munoz: I always pay attention to administrative costs. Divided over three years? 1 million of administrative costs divided over three years.

Deputy Mirzazad: Wants to thank SGC for the work on this. Adding these funds will get this up and running. Let's think about how to take this impact to the legislature so it can continue as an action.

Secretary Ross: Having pilots on this will be really informative and getting to next steps on problem solving.

#### **Council Comment:**

Deputy Secretary Moreno-Rivera: Resource Hub has been a great resource for our staff. The way it was curated is very easy to follow. Kudos to the team and the monthly calls we have really guide our department. Interagency collaboration is extremely important. There has been a lot of work on language access and talks about having resource sharing on language access on the hub. Public contracts and RFPs that have been approved to see how others have paved the way. Earlier this year we were able to align our outreach and where we break down barriers for career access through fellowships.

Deputy Secretary Radhakishna: We've really advanced the racial equity agenda. Charted JEDI Commission, and all departments have equity officers. Have been working with GovOps given Governor's Executive Order to develop recommendations for language and collaboration. We want to pay community members for their expertise and remove barriers for paying community members. We should also focus on developing data indicators on lived experience. We want to also acknowledge measurable milestones and recommendations set out in reparation report.

D'Souza: Thank you for the progress you have made on the Racial Equity Action Plan. I'm looking forward to seeing commitment to technical assistance, capacity building,



Excited to see the advance pay pilot and looking forward to the lessons learned from that pilot so that all state agencies and departments can incorporate that into grant programs. In terms of embedding equity into CalEPA, mentioned in Governor's Equity Order, data is important for this work. We created a tool that highlights redlining and how it continues to impact communities today. Racial equity is completely fundamental to the work we do.

Castro-Ramirez: Want to applaud and highlight Governor's Newsom's leadership and doubling down on our commitment to accessibility and equity. We are committed to racial equity and doing everything [possible to combat discrimination and hate. We are leading efforts on anti-hate and including a level of community dialogue. Also, providing greater resources to community members that are victims of hate and discrimination. I'm grateful we continue to make this a priority and ask agencies to continue to embed equity and what it really means.

Chancellor Munoz: I think higher education is sensitive to issues of equity. Higher education offers an expertise to achieve higher degrees of outcomes and inputs. WE need to be cognizant of the students we are serving (first-gen, Pell-recipients etc.). Are there some analytics of what folks are looking at the Hub and what is salient to users?

Secretary Ross: We have doubled down on explicit bias training for our staff and paying attention to our own staff. We are doing all that we can to help our staff develop professionally. DEI committee and Disability Advisory Committee, which we often overlook as an equity issues. We also need to think about what type of data we can collect and how it can be most helpful. There are definitely also people outside of the State of California looking at the Resource Hub and the impact goes a long way.
