The SGC has been working on a complete overhaul of its website to provide a more accessible and user-friendly interface for a variety of audiences. The creation of the site will take place in two phases, one which will include the bulk of SGC's programs and resources, and a second phase that will provide a more robust array of resources and information for stakeholders.

SGC Staff are pleased to announce that Phase I of the new website is live as of January 19, 2018. Phase II will be completed later in 2018.

E-Blast Distribution

Weekly e-blasts are sent to those who have subscribed to SGC's "General Announcements" (3,133 subscribers) and "Health in All Policies" (360 subscribers) listservs. SGC utilizes Constant Contact for this outreach.

We also have several sub-lists that serve audiences interested in specific programs on an as-needed basis. Our targeted lists include:

- Climate Change Research (312 subscribers)
- Sustainable Agricultural Lands Conservation (366 subscribers)
- Technical Assistance (292 subscribers)
- Transformative Climate Communities (892 subscribers)

On average, we have a 25-32% open rate on our messages, with a 20-25% click through rate.
