

Discussion: Goal 2 Reorganization

Feedback from last meeting:

Reorganize to clarify distinction between public and private land as two pathways for broader conservation effort focused on access for priority producers and land stewards.

Discussion:

Should Goal 2 be framed as "Statewide plan for preserved and thriving agricultural land"? If yes, will remove 2.1 and embed into context section.

Discussion: Context

Does the revised context section clarify the relationship between 1) stewarding land in the public domain and 2) ensuring a dignified living and secure retirement for producers and land stewards?

Discussion: Increasing public landholdings

Feedback to consider:

Interagency review: The costs of increasing public landholdings outweigh benefits and land becomes subject to many laws and regulations that may undermine Task Force goals.

Task Force feedback: State and local governments are ineffective at stewarding existing public lands so should not recommend an increase.

Discussion: 2.2.c.ii, prioritizing applicants

- Current recommendation: prioritize funding for applicants that "are community-based" and "practice cultural humility."
- How would these terms be defined/evaluated by program administrators? Suggested options: support letters, inclusive governance structures

Discussion: 2.2d, require land trusts & CBOs co-create conservation goals w/communities

- In what context are community-based organizations and land trusts required to do this?
 Does this belong as a sub-bullet to 2.2d in the context of grant guidelines?
- How "co-create" and with what outcome?

Discussion: Proposed recommendations from interagency reviewers

- Add a recommendation to expand funding for implementing healthy soils and regenerative agriculture practices (Currently recommend funding TA providers to support regenerative ag but not direct implementation).
- 2.2.c: This funding is much needed but seems limited in its focus on training.
 Consider adding a recommendation to support new and existing organizations' work to develop or update programs and tools to support acquisition and leasing efforts geared toward priority producers & land stewards.
- Add to 2.3.b: Establish agricultural conservation easement purchasing programs.
