#### **Council Comment**

All Council members discussed various ways to support state-local coordination toward Council Priority 3, and the valuable lessons learned from State/Local Energy & Climate Coordination's (SLECC) dashboard and reports.

**Jackson:** Mentioned the process occurring at CalSTA and the focus of their work in creating a report of recommendations.

**Torres:** Cited the need for communities to access more capital to leverage resources and state funding. Suggested that there is potential for matchmaking relationship building.

**Moss**: Mentioned participating in a previous Vienna Social Housing Study trip similar to the one Kennedy attended. Referenced the city's comprehensive social housing policy rooted in its principle that the right to housing is a human right.

**Capretz**: Noted the importance of using plain language to build a stronger connection between government and the community. Expressed interest in wanting to connect more with the community and work with partners at the state and local government level.

**Schwartz**: Mentioned her experience attending the trip to Vienna years ago and was awestruck by how accessible housing and other parts of society were in their model. Expressed importance of centering around accessibility and community.
