Investment Program Updates

Affordable Housing and Sustainable Communities (AHSC)

Staff: Amar Cid, Marc Caswell, Lisette Anzoategui, Shep Wilbun, Justin DeWaele, Brianne Logasa, Ella Manashil and California Department of Housing and Community Development (HCD) Staff

- AHSC Round 9 proposed awards will be presented at this Council Meeting with a Notice
 of Funding Availability (NOFA) of \$775 million, 21 projects are being recommended for
 award in 17 jurisdictions throughout the state.
- Events:
 - On Oct. 22, the AHSC Program celebrated the grand opening of Chris Hartmire Plaza in Pomona. The Round 6 project was awarded a total of \$27,587,829 to build 90 affordable homes, five miles of bikeway, and solar workforce programs.
 - On Oct. 29, the AHSC celebrated a groundbreaking ceremony of Sakura, a brand new 134-unit 100% affordable housing project located at 2000 16th St.
 Sacramento, CA 95818 in the heart of Sacramento, CA. The ground floor will be retail stores along with on-site programs for residents focused on financial literacy, digital skills, and wellness. The project was funded in part by an AHSC award of \$38 million.
 - On Oct. 30, the AHSC Program celebrated the groundbreaking of the Sunnydale 3A + 3B development that will construct 1,770 residential units, including 975 affordable units and 694 market rate units. The project will include a Class IV bike facility, Class I bike path, crosswalk, a playground and a monthly unlimited transit pass for three years for all restricted units. Sunnydale HOPE SF is a longterm, multi-phase project that includes the complete rebuilding of the Sunnydale-Velasco Housing Authority site.
 - On Nov. 4, the AHSC Program celebrated the groundbreaking of Alder Square in San Bernardino. The Round 8 project was awarded a total of \$15,847,276 to build 91 affordable homes, create nearly three miles of new bikeway, and purchase four new ZEV transit vehicles.

Transformative Climate Communities Program (TCC)

- Staff continue to process advance pay requests and provide assistance to Round 4 and Round 5 grantees as authorized by AB 156 (2022), AB 590 (2023) and AB 3017 (2024). To date, staff have processed eight advance pay requests.
- Staff released Draft Program Guidelines and a Summary of Changes report in anticipation of Proposition 4 funding on Sept. 29. Public comment is open until Jan. 2, 2026. In coordination with the Community Resilience Centers Program (CRC) staff have



- hosted four input sessions and have six small focus groups planned for December and early January.
- Staff hosted an informational webinar for a Request for Informational Application Technical Assistance for TCC and CRC upcoming funding rounds.
- Staff have attended several site visits including:
 - Oct. 16 TCC and DOC staff traveled to Chicken Ranch Rancheria (R4, Planning, \$217,000) to attend a community meeting with residents from the Chicken Ranch Rancheria Tribe and Historic Jamestown.
 - Oct. 19: City of Stockton (Round 4, \$24M) partners Edible Schoolyard Project and Public Health Advocates hosted a Fall Fest on the Block, a community block party that celebrated culture, connection, and climate justice. The event featured music, cooking demonstrations, a youth walk, organic produce, and an Exchange Station.
 - Oct. 22-24: Staff met with the Program Managers for PACT for Paramount (Round 5, \$300,000) and attended the City Housing Forum on October 23rd. They also met with the Pomona ACTS team (Round 5, \$22M) and attended some community events in-person.
 - Oct. 28 Community Partners (Round 2, \$22M) partner Pacoima Beautiful youth cohort traveled up north for Sacramento Day. The Pacoima Beautiful cohort met with staff and toured the California Environmental Protection Agency (CalEPA) and SGC offices.
 - Nov. 6 Santa Barbara County (Round 5, Project Development Grant, \$1.1M) hosted a site visit in Cuyama Valley for SGC staff.

Sustainable Agricultural Lands Conservation Program (SALC)

Staff: Amar Cid, Shanna Atherton-Bauer (DOC) and DOC Staff

- The SALC team presented recommendations at the October Council meeting to award approximately \$124.5 million in funding to four planning grants, eight fee title, and 39 conservation easement acquisition grants. SALC staff also recommended that one additional fee acquisition project be awarded contingent on funds becoming available to cover the full project cost by Nov. 26. The SGC adopted all recommendations for awards. Funds projected to come available for the contingent project have since cleared. SALC staff are working on entering grant agreement with awardees for four planning grants, nine fee title and 39 conservation easement acquisition grants.
- The SALC team will present recommendations to the December Council to award \$2,051,490 in funding for 14 capacity awards. The recommended capacity grants span 25 counties, including one identified as Statewide.
- Beginning Oct. 15, 2025, SALC Staff have opened a new solicitation process for the Agricultural Conservation Acquisition grant program (conservation easement and fee title purchases). Applicants work through a required two-phased pre-proposal process, and there are two application deadlines per year; Jan. 15 and June 17 in 2026. Staff anticipate this will improve readiness of conservation acquisition proposals and project



- alignment with SALC Program priorities. These changes are permitted in the approved guidelines and facilitated by a technical amendment approved at the August SGC meeting.
- Staff reported two conservation easement closings between Sept. 15 and Nov. 14. These projects in Santa Barbara and Sonoma Counties conserved a combined 971 acres of grazing land.
- Between Sept. 15 and Nov. 14, SALC staff submitted 30 invoices totaling \$2,201,336 to DOC Accounting for payment. This includes one acquisition invoice, payments for associated costs related to acquisition transactions, payments for capacity and project work, and payments for planning work.

Community Resilience Centers (CRC)

Staff: Amar Cid, Anna Jane Jones, Dora Monterroza, and Jessica Cervantes

- Staff released Draft Program Guidelines and a Summary of Changes report in anticipation of Proposition 4 funding on Sept. 29. Public comment is open until Jan. 2, 2026. In coordination with the CRC Program, staff have hosted four input sessions and have six small focus groups planned for December and early January.
- CRC and TCC Staff launched a joint Application Technical Assistance (TA) Request for Information (RFI). The RFI shared information on a future Application TA solicitation to determine if requirements can be met by the bidder community.
 - Staff hosted an RFI Q&A Webinar on Nov. 3. 102 individuals representing over 66 organizations and tribes registered; 63 participants attended.
 - o The RFI closed on Nov. 14 and received 13 responses, a record- high. Past typical yield has been 2-4 responses for similar TA RFI postings at the Governor's Office of Land Use and Climate Innovation (LCI)/SGC)
- The CRC team welcomed four new staff and one student assistant, who joined the team Dec. 8.
- CRC Staff conducted site visits, including:
 - Oct. 7 Mattole Restoration Council (Round 1, Planning, \$498,139) hosted a site visit for SGC Staff at their Mattole Resilience, Education, and Research Center Project site in Petrolia, CA. The site visit included touring their hoped-for CRC Facility Site, the local community, and local partners' sites part of their Collaborative Stakeholder Structure.
 - Nov. 24 CRC staff traveled to Casa Familiar's future La Semilla Community Resiliency Center (Round 1, Implementation, \$8.4M) construction site to attend a community event where CRC staff met with Casa Familiar staff and their Partners to receive an update on the construction process which included showcasing the use of cross-laminated timber (CLT).



Community Assistance for Climate Equity (CACE)

Staff: Hoi-Fei Mok, Ena Lupine, Blanca Escobedo, Markie Price and Nancy Cheng

- Regional Climate Collaboratives (RCC) Program: SGC Executive Director and staff hosted an in-person RCC Fall Convening Nov. 5-6 in Rancho Cucamonga with support from the RCC technical assistance team. This event brought the grantees together in person one last time before their grants end in 2026 to share successes and lessons learned through their RCC grant and identify strategies to keep the collaboratives active after their grant term ends. Staff will continue hosting virtual peer learning sessions until the end of the grant term in June 2026.
- Tribal Capacity Building Pilot Program: SGC Executive Director and staff attended site visits to the Winnemum Wintu Tribe on Oct. 28 and Mooretown Rancheria on Oct. 29. All grantees joined an in-person peer learning session with SGC staff and the TA team on the lands of the Pala Band of Mission Indians on Nov. 4. The session was well attended, and grantees discussed topics as varied as governance, land acquisition, and staffing.
- BOOST: SGC and Freedman Consulting LLC hosted an Imperial Valley Civic Ecosystem Initiative (IVCEI) funder call on Oct. 9 to update philanthropic funders who are active in the Imperial Valley about the IVCEI's work thus far. During the call, Imperial Valley Equity and Justice Executive Director Daniela Flores presented about the challenges she is seeing on the ground related to capacity needs and the impacts of federal policies. The SGC's IVCEI partner the Institute for Local Government hosted a grant writing training for local government and community-based organization staff in the Imperial Valley on Nov. 20. SGC continues to coordinate regularly with the ICVEI partners and philanthropic funders focused on the Imperial Valley region. The SGC will release its second quarterly newsletter "Imperial Impact: Interagency & Partnership Highlights" in December, which provides updates on state initiatives and their impact on the Imperial Valley and the broader Salton Sea region.
- Tribal Housing and Capacity Building Program: Staff are working to finalize draft Program Guidelines for the Tribal Capacity Building Program and the Tribal Housing Pre-Development Program, which they plan to release by the end of 2025. These Guidelines will incorporate feedback gathered through the 10 Key Informant Interviews staff help in Summer 2025. Staff plan to launch a tribal consultation process and a workshop series in 2026, aiming to finalize both Program Guidelines by spring 2026.
- Interagency Technical Assistance and Capacity Building Work Group: The CACE team
 facilitates a regular interagency work group to share best practices across agencies
 related to offering technical assistance and capacity building support to California
 communities. Staff are preparing for the next bimonthly work group meeting on Dec.
 18. The CACE team has also released the <u>Tribal Technical Assistance Guidance</u> section to
 the <u>TA Toolkit</u>. This new section includes background on California's unique historic
 relationship with tribes, a set of core principles, best practices for developing a Tribal-



specific TA program, resources from our state agency partners, and a Tribal-specific glossary

Collaborative Policy Initiatives

Health and Equity Program (HEP)

Health in All Policies (HiAP)

Staff: The SGC partners with the California Department of Public Health (CDPH) and the State of Equity to staff the Health in All Policies (HiAP) Task Force. The Task Force brings together over 30 agencies, departments and commissions to integrate health into programs and policies that advance state priorities.

- **15-Year HiAP Milestone:** The California Health in All Policies (HiAP) Task Force is celebrating 15 years of work in 2025. To celebrate this milestone, HEP contracted with the State of Equity to develop the HiAP 15-Year Anniversary Report. This report shares the history of HiAP, the priorities it has set, major accomplishments, and best practices to advancing a HiAP approach. HEP and the State of Equity will publish and share the report publicly in 2026.
- HiAP Task Force hosts quarterly interagency convening. HEP and HiAP partners hosted an in-person HiAP Task Force Quarterly Meeting on Dec. 10 in Sacramento. The meeting featured a presentation of HiAP's 15-year Anniversary Report and a Recommendations Report for 2026.
- Health in All Policies Recommendations Report: HEP is working with the Equity and
 Wellness Institute (EqWI) to continue the evaluation of HiAP and use the findings to
 develop a set of recommendations for efforts in 2026 and beyond. The report includes
 strengths and opportunities for growth, priorities, goals, member and partner
 engagement strategies, and a foundation for action plan development. HEP and EqWI
 will continue work through next year to finalize new action plans for HiAP, which will be
 shared in December 2026.

Organizational Initiatives

- **SGC Program Highlights:** SGC staff prepared highlights showcasing increased access to programs by California communities. HEP compiled the program and initiative highlights in the Council Agenda Item 6 Staff Report.
- SGC/LCI Workforce Experience Survey: In May, HEP administered the 2025 Workforce
 Experience Survey with SGC staff to learn about staff experience. HEP is now supporting
 LCI with administering the same survey to all LCI and Shared Services staff. Findings
 from both surveys will be combined for analysis and HEP will develop recommendations
 for Leadership based on the survey findings. HEP aims to complete the analysis and
 development of recommendations by March 2026.



Natural and Working Lands

California Agricultural Land Equity Task Force

- The tenth and eleventh California Agricultural Land Equity Task Force (Task Force) meetings occurred Oct. 15 and 16 in Ventura and Nov. 13 in Berkeley, respectively. In both meetings, the Task Force discussed and revised its Draft Report.
- On October 24, the Task Force Vice Chair, a Task Force member, and SGC/LCI staff met with the Karuk Tribe Chairman, leaders, and staff to discuss the Task Force's Draft Report. The Task Force considered input from this meeting at the Nov. 13 Task Force meeting.
- The next Task Force meeting is scheduled for Dec. 11 at the California Endowment in Sacramento. The Task Force will finalize its recommendations and vote on the submission of its Final Report in advance of the Jan. 1 deadline.

Federal Funding Initiatives

Connecting Communities

Staff: Adrienne Moretz

- **Technical Assistance:** Connecting Communities is supporting previous SGC grant applicants and awardees to apply for and receive grants. The team is supporting communities with executed or cancelled federal agreements to navigate the change in federal administration.
- Catalyst Convenings: The SGC Connecting Communities team, with LCI, is planning for additional Catalyst Convenings across the state in the coming months. The first event in 2026 is tentatively scheduled for late February. The events are a continuation of the commitments made at the 2023 and 2024 Catalyst Conferences. The goals of the Convenings are to:
 - Exchange knowledge, best practices, and successes about community-driven climate, energy, and land use efforts
 - Connect directly with state representatives and regional assistance providers to learn about and better leverage available resources, upcoming grant programs, technical assistance and capacity building programs, active engagement opportunities, and more
 - Understand the region's priorities and co-create a set of regional and state focused policy actions, to guide SGC's strategic planning and work

Energy Investments

Factory-Built Housing (FBH) Pre-Development Pilot Program

The revised guidelines for the <u>SGC FBH Regional Pilot Program</u> were released for a 30-day public comment period on Sept. 10. This period included two public webinars to



- collect comments and targeted outreach to regional entities to promote the program and collect additional feedback on the guidelines.
- FBH Program Staff incorporated webinar and individually submitted public comments to the Program's Round 3 Final Guidelines. The Round 3 guidelines will be presented to Council for adoption on Dec. 10.
- FBH Program Staff is simultaneously developing the Notice of Funding Availability, Application materials, and Application Technical Assistance for Round 3 Applicants, with applications tentatively scheduled to open early 2026.

Energy Investments

Staff: Sean Kennedy and Mel Moyce

- Energy Policy Specialist Mel Moyce attended the California-Germany Agrivoltaics
 Conference on Nov. 5 in Davis. Hosted by UC Davis in partnership with German research
 and industry leaders, the convening explored emerging dual-use land management
 models that integrate solar generation with agricultural production. Mel's attendance
 provided SGC with early, strategic insight into a rapidly expanding clean-energy land use
 model, and how clean energy can support, rather than displace, rural communities.
- Deputy Director of Energy Investments Sean Kennedy participated in the "Biomass & Beyond: Growing a Resilient Regional Bioeconomy" symposium, hosted by Valley Vision in Sacramento on Nov. 5. The event focused on scaling up regional and statewide opportunities for biomass and bio-waste utilization, while emphasizing the cross-sector benefits of a robust bioeconomy. Participants heard from state and local experts, explored innovative regional projects, and gained insights into policies and programs that support sustainable biomass solutions. The symposium highlighted how these efforts contribute to building a resilient, circular economy.
